4.5 Computer, Internet access, training to teachers and students and any other programme for technology upgradation

The college has procured additional 25 PCs of Dell Second Generation with 4 GB RAM and 1 TB HDD. Along with these new one, we are having total 105 Computers. The college has broadband internet connection from BSNL under unlimited downloading plan. In office, the college has College Management System (CMS) software, this year it has been upgraded with additional version as CMS 10.0. The upgraded version is provided by CMS Nagpur. The changes in software have been on server as well as on client side, for college sections.

In English Language Laboratory, is fully engaged with the English speaking courses. This laboratory provides English language training to speak and learn using computers and English language software. As more number of students from remote area takes the use of this course. The Lab has 11 computers with 10 headphones and 10 speakers, projector which is fully networked with 16 port switch and internet facility.

Computers are given to other departments with updated / upgraded version for teaching, learning and evaluation with some additional accessories like printer, scanner and projector with internet facility to each department for conducting lectures using ppt.

The college has already procured SOUL software from Inflibnet for Acquisition, Catalogue, Circulation, Serials, General operation. Student can access the books which they required using OPAC server. All the above have been upgraded in time.
